- HS code verification for imports into Canada

 - *Advance rulings for tariff classification assign a 10-digit tariff classification number to imported commercial goods and include a rationale to explain why that number is the correct one to use. For origin, these rulings, in combination with the tariff classification number, help you determine whether imported commercial goods qualify as originating goods and are entitled to the benefits of preferential tariff treatment under a free trade agreement.

- With verified HS code, identify US tariff exposure on Canadian made goods
 - Tariff Finder Government of Canada assess applicable tariffs by HS code or product description for products made in a country with an FTA with Canada (import and export). Some limitations apply, for example (1) Tariff Finder only reflects present moment applicable tariffs and (2) softwood lumber dispute tariffs are not included.
- Identifying tariff exposure on imports from US by Canadian retaliatory tariffs
 - o US imports impacted as of March 3 list
 - US imports impacted as of March 13 list
 - US imports possibly impacted as of April 2 list (not yet implemented as of March 16)

Ensure customs broker bond sufficiency

- US bond calculation
 - 10% of total amount of last 12 months
- Canada bond calculation
 - 50% of highest monthly balance within last 12 months
- Avoid bond stacking (multiple bonds outstanding)

Canadian tariff on US goods – CBSA remission request

The Department of Finance has introduced a formal process for requesting tariff remission on certain goods imported from the United States. Remission may be granted on a discretionary basis, in response to exceptional and compelling circumstances that, from a public policy perspective, are found to outweigh the primary rationale behind the application of the tariffs. Canadian-registered companies may apply under two specific circumstances:

- To address situations where goods used as inputs cannot be sourced domestically, either on a national or regional basis, or reasonably from non-U.S. sources.
- To address, on a case-by-case basis, other exceptional circumstances that could have severe adverse impacts on the Canadian economy.

Inquiries or remission requests must be submitted to remissions-remises@fin.gc.ca, including "U.S. Remission" in the subject line, and contain the information set out in the Department of Finance's template.

Sensitivity / Scenario Analysis

The idea here is to simulate business growth / contraction with your company financial statements such as budgets, profit & loss statement and cash flow statement. For example, if your revenue (top line) grows / contracts by x%, what must change throughout your cost structure to remain profitable.

<u>Financial Performance Data</u> Government of Canada benchmarking and competitive analysis tool

<u>Synario</u> – customizable, built-to-scale financial planning & analysis (FP&A) solutions that bridge the gap between short-term budgeting and long-term forecasting. Ideal for corporations, higher education, public sector, water & utilities, transit agencies, ...

c. Sample strategy for scenario & sensitivity analysis

- 1. Define Key Variables
 - Identify the variables most likely affected by tariffs (e.g., sales volume, cost of goods sold, exchange rates). These will be the focus of your sensitivity analysis.
- 2. Simulate Revenue Loss Scenarios
 - Create multiple scenarios with varying levels of revenue loss (e.g., 10%, 20%, 30%) due to reduced exports or higher costs from tariffs. Use tools like Synario or Excel to model these scenarios.
- 3. Adjust Cost Structures
 - Explore cost-saving measures such as renegotiating supplier contracts, optimizing inventory management, or reducing waste.
- 4. Incorporate External Factors

 Consider macroeconomic impacts such as currency depreciation or inflation due to tariffs. For example, the Bank of Canada's analysis shows that tariffs can lead to higher costs for imported goods and reduced demand for exports.

5. Visualize Outcomes

- Use software with visualization capabilities (e.g., Synario) to compare the outcomes
 of different scenarios side by side. This helps in identifying which combination of
 cost adjustments and strategic changes is most effective.
- 6. Stress Test Your Model
 - Perform sensitivity testing by varying one key variable at a time (e.g., sales price or volume) to understand its impact on profitability.

By leveraging these tools and strategies, you can better prepare your business to navigate the opportunities and challenges while aiming to maintain profitability.
